Index Overview

The market closed red today. The benchmark index DSEX (-0.28%) lost 16.85 points and closed at 6058.39. The Shariah-based index DSES (-0.17%) and the Bluechip index DS30 (-0.38%) closed at 1322.65 and 2075.88 points, respectively. The Engineering Sector booked the highest turnover with 19.26%, followed by the Pharma & Chemical and Food & Allied sectors with 17.70% and 16.13% respectively. Block trades accounted for 9.06% of overall market turnover.






